Mr. Lathia will act as Fund Manager - Foreign Securities for all eligible Scheme(s) of HDFC Mutual Fund for making investments in ADRs/ GDRs / Foreign Securities and Overseas Exchange Traded Funds (ETFs) from the Effective Date. Mr. Lathia will also handle research responsibilities.

Mr. Lathia, aged 32 years, has collectively over 9 years of experience in equity research. His previous employment was with BRICS Securities Ltd. (June 2004 - December 2006), Enam Securities Pvt. Ltd. (January 2004 to May 2004) and SSKI Securities Pvt. Ltd. (January 2001 - December 2003). He is a Graduate in Commerce, an Associate member of the Institute of Chartered Accountants of India and Chartered Financial Analyst (CFA) from Association for Investment Management and Research (AIMR).

2. Mr. Anand Laddha, Manager - Equities & Fund Manager - Foreign Securities, who is a Key Personnel of HDFC AMC since February 2006, is now being redesignated as Senior Equity Analyst & Equity Dealer (Back-up). Mr. Laddha shall cease to be a Fund Manager - Foreign Securities from the Effective Date.

Mr. Laddha, aged 30 years, has collectively over 6 years of experience in Equity & Derivative Research and Sales and Fund Management - Foreign Securities. His previous employment was with Refco-Sify Securities India Pvt. Ltd. (September 2004 - February 2006) and Alchemy Share & Stock Brokers Pvt. Ltd. (August 2003 to September 2004). He is a Graduate in Commerce and an Associate member of the Institute of Chartered Accountants of India.
